**Laboratory note:** The estimated concentration of the unknown peak in the sample is 3.10 mg/g | Currently PharmLabs laboratory can not confirm an unidentified peak in your chromatogram due to interference (only with highly concentrated D8 products) from which we believe to be either (+)- $\delta^8$ -THC or  $d^9$ -THC. At this time there are no reference standards available for (+)- $\delta^8$ -THC. (+)- $\delta^8$ -THC is a different compound from the main (-)- $\delta^8$ -THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)- $\delta^8$ -THC and  $d^9$ -THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (+)- $\delta^8$ -THC and  $d^9$ -THC with the majority, if not all, of the concentration being (+)- $\delta^8$ -THC. Total (+/-)  $\delta^8$  Concentration is estimated to be 24.50 mg/g.
