Summary **D9C**: The total **Δ9-THC** content in this sample is 0.27%. For the most accurate **Δ9-THC** concentration, refer to the GC MS/MS section of this COA. This sample was tested using HPLC and GC MS/MS. HPLC analysis can yield inconsistent results for **Δ8-THC** and **Δ9-THC** due to isomer interference. GC MS/MS was employed to avoid this issue. Please note, if THCa is present, the **Δ9-THC** level measured by GC MS/MS might be higher due to decarboxylation.
