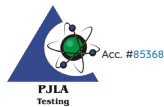

At this time there are no reference standards available for (+)-THC. (+)-THC is a different compound from the main (-)-THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)-THC and (-)-THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (+)-THC and (-)-THC with the majority, if not all, of the concentration being (+)-THC. Total (+/-) D8 Concentration is estimated to be: 72.17%
